The following is waived for those eligible for the Expedited Application to M.Arch: the GRE, one letter of recommendation, and the application fee. The English proficiency test requirement will be waived for international students who have conferred, or will confer, a bachelor's degree at Pratt Institute. Note: If it has been more than 2 years since your graduation you will be required to submit new English language proficiency scores (TOEFL, IELTS, or PTE).

Eligibility for the Expedited Application: Pratt undergraduates completing a bachelor's degree in any program may apply to the M. Arch Expedited Application.

How to apply: Please express interest in the Expedited Application in your Statement of Purpose. The fee waiver must be secured **before** you apply by following instructions on our [application fee waiver page](#).

Expedited Application Requirements: Applicants should have conferred, or will confer, a four-year bachelor's degree from Pratt Institute in any area of study. Applicants must present a portfolio providing evidence of their interest in architecture or their visual sensibility through the media of their choice—photography, drawing, essays, videos, etc. Students interested in the Expedited Application must designate this on their statement of purpose. The statement should be no more than 500 words. One letter of recommendation is required; the second letter will be waived by an admissions counselor upon submission of the application. Portfolios must be submitted online at pratt.slideroom.com. **The GRE is waived.** If you wish to submit scores, the GRE code is 2669.

The following is waived for those eligible for the Expedited Application to M.S. Arch: one letter of recommendation, and the application fee. The English proficiency test requirement will be waived for international students who have conferred, or will confer, a Bachelor of Architecture degree at Pratt Institute. Note: If it has been more than 2 years since your graduation you will be required to submit new English language proficiency scores (TOEFL, IELTS, or PTE).

Eligibility for the Expedited Application: Pratt Bachelor of Architecture undergraduates (five-year program) are eligible for the M.S. Arch Expedited Application.

Portfolio should be submitted at pratt.slideroom.com. Students interested in the Expedited Application must designate this on their statement of purpose. The statement should be no more than 500 words. One letter of recommendation is required; the second letter will be waived by an admissions counselor upon submission of the application.

[Expedited Application Process for Pratt students to the Post-Professional Urban Design M.S. \(Fall only\), Brooklyn Campus \(STEM\)](#)

An Expedited Application is offered to Pratt Bachelor of Architecture undergraduates (five-year program) who have conferred, or will confer, their degree with us and would like to continue into the M.S. Urban Design program with abbreviated application materials and waived application fee.

An Expedited Application process is offered to Pratt undergraduates who have conferred, or will confer, a bachelor's degree with us and would like to be considered for the Art and Design Education M.A. with abbreviated application materials and waived application fee.

The following is waived for those eligible for the Expedited Application to Art and Design Education M.A.: one letter of recommendation, and the application fee. The English proficiency test requirement will be waived for international students who have conferred, or will confer, a bachelor's degree at Pratt Institute. Note: If it has been more than 2 years since your graduation you will be required to submit new English language proficiency scores (TOEFL, IELTS, or PTE).

Eligibility for the Expedited Application: Pratt students currently studying in, or who have completed a Pratt undergraduate degree with a minimum of 25 credit hours in art, design and/or the history of art may apply to Art and Design Education M.A. Expedited Application. Candidates must have a minimum, cumulative grade point average of 3.0 or higher in their undergraduate program.

Expedited Application Requirements: All applicants to the Art and Design Education M.A. must submit a portfolio of 15 images of work (submit online at pratt.slideroom.com) and a written statement of purpose expressing interest in the Expedited Application (uploaded to the application.). The graduate admissions committee uses standard rubrics to assess the portfolio and written statement of purpose. The statement of purpose should note interest in the Expedited Application and be no more than 500 words. Only one letter of recommendation is required; the second letter will be waived by a counselor upon submission of the application. Applicants are contacted for a Skype interview when all credentials have been received and reviewed.

Note: New York State has eliminated the GRE requirement for admission to graduate education programs entirely, which takes effect immediately. This information has been updated as of November 19, 2021 and applies to the Fall 2023 application season and beyond.

The Art and Design education programs are New York State Education Department (NYSED) "approved teacher preparation programs" and meet the new requirements for New York State Initial Teacher Certification in Visual Arts PreK-12. However, in order to be recommended for New York State Initial Certification in Visual

Arts PreK-12, candidates must also have completed the following workshops: *Child Abuse Identification Workshop*; *School Violence Prevention and Intervention Workshop*; and *DASA: Training in Harassment, Bullying, Cyberbullying, and Discrimination in Schools: Prevention and Intervention*. These workshops must be taken with a provider approved by NYSED. Passing scores on the following tests and assessments, Educating All Students (EAS); Content Specialty Test (CST) and Education Teacher Performance Assessment (edTPA), are also required.

Candidates must have a minimum, cumulative grade point average of 3.0 or higher in their graduate program.

Expedited Application Requirements: All applicants to the Art and Design Education M.A. must submit a portfolio of 15 images of work (submit online at pratt.slideroom.com) and a written statement of purpose expressing interest in the Expedited Application (uploaded to the application.). The graduate admissions committee uses standard rubrics to assess the portfolio and written statement of purpose. The statement of purpose should note interest in the Expedited Application and be no more than 500 words. Only one letter of recommendation is required; the second letter will be waived by a counselor upon submission of the application. Applicants are contacted for a Skype interview when all credentials have been received and reviewed.

Note: New York State has eliminated the GRE requirement for admission to graduate education programs entirely, which takes effect immediately. This information has been updated as of November 19, 2021 and applies to the Fall 2023 application season and beyond.
